We urge you to vote your shares in advance of the meeting by signing and returning the proxy form previously provided to you, or by voting online or by telephone in accordance with the instructions previously provided to you. This will ensure your shares are represented and voted at the meeting, and will ensure the presence of a quorum in order to conduct the business of the annual meeting. While you will be able to vote your shares on the day of the meeting, we respectfully ask that you vote prior to the meeting in order to facilitate this process.

Finally, in order to limit exposure time, proceedings of the meeting will be limited solely to the formal business described in the notice and proxy statement previously delivered to you.
