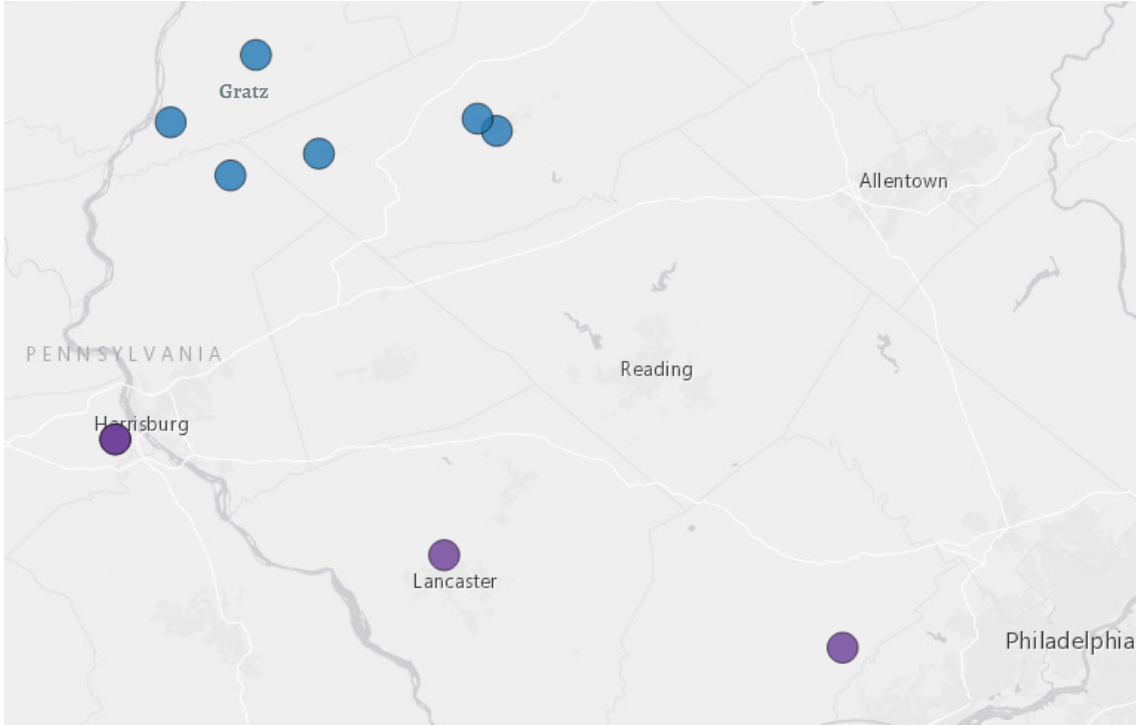
ABOUT LINKBANCORP, Inc.
